

XIX ALGARVE INTERNATIONAL DANCE SUMMER SCHOOL

15th to 28th July 2019

Rules and Regulations

1. Organisation

The organisation of this event is promoted by the Association “BCC – *Beliaev Centro Cultural*”.

2. Conditions of participation

Open to all dancers from the age of 6, irrelevant of their experience in Dance. In some subjects, there will be specific age limits (see registration form).

3. Levels

Participants are distributed amongst different levels: Beginner, Medium, Advanced and Adult. In some subjects, levels may be created or eliminated, insofar as the Organisation deems them to be necessary.

4. Teachers

The Organisation reserves the right to substitute Teachers who have been announced, if any are unable to attend the summer school or for any other reason, not involving the Organisation.

5. Classes

a) Duration

According to the subjects and their levels, each class will last between 50 and 80 minutes.

b) Schedule

Lessons will take place Monday to Saturday, with a daily lesson for each class/level.

The final schedule will be posted on the website www.dancarte.org and affixed on the information board at Espaço.d, Rua Frei Lourenço de Sta. Maria 1C 8000-352 FARO, from 28th June 2019.

6. Rules of Conduct

- Non-participants will not be allowed to frequent the School.
- Participants should behave in an appropriate manner whilst in the School, without disturbing the general functioning of the ongoing classes and respect and follow all instructions given by the Organisation.
- Access to the studio is restricted exclusively to participants of each lesson.
- Entrance to the practice rooms is only permitted with appropriate footwear.
- It is strictly forbidden to eat in the changing room or in the studio.
- Each participant is responsible for their personal belongings; the Organisation is not responsible for any theft, damage or loss of any objects.

7. Health problems and insurance

During registration, participants should inform the Organisation in writing of any allergies or other health problems. In such cases the Organisation or the Teachers reserve the right to limit access, totally or partially, to classes, and participants should abide by such instructions.

The Organisation will not be held responsible for any accident or injury that may occur throughout the duration of the Summer Course.

Students may choose to acquire personal accident insurance, by selecting this option during the registration process. Students from CDA are already covered by the school's insurance policy.

8. Registration

a) Registration takes place in the following manner:

2. After receiving an e-mail with the due value, payment must be made at the secretariat (Espaço.d)

b) Registration and payment should occur until 20th June 2019. Any registration after this date will be limited by the number of places available.

c) Payments are non-refundable.

10. Travel and accommodation

Any costs involving travel and accommodation are the exclusive responsibility of the participants.

11. Final Gala

On the last day of the Summer School (Sunday), the Gala will be held. **Participants will be selected by the Teachers of the various classes.** Any decision to exclude participants from the Gala will not be subject to any appeal and will be final as soon as decision is given to the participant.

Participation in the Gala is not compulsory, however, if participants do not intend to participate they should inform the school of this during the act of registration, so that choreographies may be conceived and executed with this information in mind.

12. Final Dispositions

Registration in the XIX Summer School implies acceptance of the present rules and regulations.

It is competence of the Organisation to decide upon any matter not foreseen within the present Rules and Regulations.
